#### Who can attend classes?

Helena College Community Education classes are open to all Helena-area adults. In most cases, students under 18 will be permitted only with prior consent of the parent, instructor, and staff. Most

classes are intended for adults, but in some cases. students under 16 may enroll with a paying adult. Please ask!

#### Do I have to register in advance?

YES! Some last-minute registrations are possible. but sooner is better than later! Many of our popular classes fill early. All classes have a minimum number of participants in order to run, and if we have not met the minimum number three days before the start of the class, we may have to cancel. On the first day of class, we print a final roster and prepare other paperwork a few hours in advance. Our instructors do not take registration or payment at class.

#### What if I have to cancel?

Please contact our office as soon as possible. If you cancel three or more business days before the first class meets, we will refund your registration, minus 10% for processing. If you cancel less than three days out, we may be able to give a partial refund, or transfer your tuition, depending upon the circumstances.

#### What about parking?

Parking permits are required from 8 am until 5 pm weeknights. If your class begins before 5 pm, you will be given a temporary pass, which will be sent via email, or can be picked up at the first session. If visiting campus before 5 pm and do not have a pass, please park along the street (Livingston, Sanders, or Townsend) to avoid being ticketed.

#### How will I know where to go?
