

# HEERF III Funding Report and Disclosure

Higher Education Emergency Relief Fund III (HEERF III)

ARP Act Funding Report and Disclosure

Funding has been allocated under the Higher Education Emergency Relief Fund II (HEERF II) from the American Rescue Plan (ARP) Act that was signed into law March 11, 2021. These funds have been provided by the federal government to directly support students facing urgent needs related to the COVID-19 pandemic. Helena College University of Montana has disbursed funds as emergency grants to students in accordance with federal guidelines for this funding.

Helena College received \$1,243,261 from the U.S. Department of Education to support students. As of September 23, 2021, approximately \$548,578 has been distributed to 678 students. This amount will be updated every fiscal quarter as prescribed by the Federal Department of Education.

Out of the College's eligible population for the spring 2021 term, three tiers of approximately 870 students were eligible to receive Emergency Financial Grants under CRRSAA.

The methods used to determine which and how many students received in emergency fund grants under section 18004(a)(1) of the CRRSA Act follow:

- Undergraduate degree seeking students who were enrolled as of May 15, 2021.
  - This was updated at the start of the Fall 2021 term to include any student regardless if degree or non-degree seeking.
- Any student with an outstanding balance from the Spring 2020 term through the Summer 2021 term.
- Students who were enrolled exclusively in online programs were included.
- Dual enrolled students and Continuing Education students were included.
- Eligible under section 484 in Title IV of the [Higher Education Act of 1965](#).
- Awards will be prioritized based on the 2020/2021 Expected Family Contribution (EFC) which is the value calculated because of your 2020/2021 Free Application for Federal Student Aid as of May 15, 2021.
  - Updated to the 2021/2022 FAFSA at the start of the Fall 2021 term.
- Helena College has selected an approach to equitably help as many eligible students as possible, prioritizing need based on the calculated EFC and institutional cost of attendance with a three tiered approach.
- Students will be contacted in need order to allow for distribution and evaluation of resources.
- Students will also be pointed towards other entities for assistance, such as SNAP, LIHEAP, and unemployment.
- Approximately 72% of the ARP student funds were utilized for the auto awards within the three tiered approach. Approximately 4% was reserved for continuing education students, and less than 1% was reserved for dual enrolled students. The remaining 23% will be utilized to assist students who submit an emergency need application. These funds will be disbursed via an application or appeal process that has been distributed via email.

Instructions, direction, and guidance were provided to eligible students by email and subsequent application. The application certifies that eligible students had a qualifying expense [[1](#)] or hardship related to COVID-19 campus disruption.

1. Qualifying expenses include but are not limited to technology and connectivity needs related to distance learning, books and other instructional expenses for online modality, medical/healthcare costs, childcare, and food insecurity.
