Pathway Advising Notes: The PT pathway will look different sequentially than the FT pathway because it's important that students take the accounting sequence (101, 102, 201 and 202) in order and and in consecutive semester. All courses are the same as the FT pathway.

Course Advising Notes: CAPP156: CSCI 172 can be substituted for this course.

WRIT101 or WRIT122: WRIT 122 is the preferred course for this pathway.

COMX111 or COMX115: COMX 115 recommended for this degree.

ECNS201 or ECNS202: Notes Both courses offered on rotation every fall, spring, and summer semesters.

ACTG298: Notes Students have the choice of an Elective Course or any general Elective Course will work, recommend a business elective course. Transfer credits may work as elective course.
